**ARTS AND CRAFTS AND COMMERCIAL VENDORS
MUST FOLLOW THE FOLLOWING RULES:**

If an item is bought somewhere else and resold, it is considered commercial. If the item is handmade completely, then it qualifies as a craft. Half and half will be considered commercial. AOB does not guarantee exclusivity, but will try to limit duplicate merchandise sold. The board will monitor booths.

Absolutely no offensive, racial, drug related merchandise will be tolerated. No pepper spray, fireworks, knives or guns allowed. AOB reserves the right to remove any items deemed unsuitable or unsafe for a family oriented festival. Failure to comply will cause immediate shutdown of your

booth, NO REFUND will be given, and you will not be able to load a vehicle until the close of the festival.

Security is provided on Thursday night before the festival begins, as well as Friday and Saturday nights. Vendors are responsible for securing their own property when the festival shuts down each night. AOB is not responsible for lost or stolen items.

Booths must be set up before 5 p.m. on the Thursday before the festival. All vendors must open at 3 p.m. on Friday and remain open all hours that the festival is open. (Any deviation needs to be cleared by AOB prior to Friday at 3 p.m.). Breakdown is at 6pm on Sunday.

ALL VEHICLES MUST BE OFF THE GROUNDS OF THE FESTIVAL BEFORE 3 P.M. FRIDAY AND NO VEHICLES WILL BE BROUGHT ONTO THE GROUNDS UNTIL AFTER 6 P.M. SUNDAY! NO EARLY BREAKDOWNS !

Vendors will occupy only the space provided to them by the board.

Violations of any terms will result in the vendor being asked to leave with NO REFUND.

A list of items you sell must accompany this form before approval. No variance of those items will be sold unless approved by the board.

Each vendor is responsible for keeping their area clean and safe. Place trash in dumpsters for morning pickup.

You will be contacted about date and time of setup. All fees are non refundable. AOB will not be liable for any injuries, weather conditions, acts of GOD, loss of income, loss or damaged supplies/equipment, nor does it guarantee a profit of any type.
